

# WODDITY's 2019 CrossFit<sup>®</sup> Games Bracket Challenge Rules, Terms, and Conditions

## 1. KEY TERMS AND PHRASES

- a. **2019 CrossFit Games:** The 2019 Reebok CrossFit Games, as run by CrossFit, INC.. Also referred to as "CrossFit Games".
- b. **2019 CrossFit Open:** The 2019 CrossFit Open, as run by CrossFit, INC.
- c. **Bracket:** The online-submitted bracket entry, as administered by Brackify and WODDITY, INC.. Also referred to as "CrossFit Open".
- d. **Category:** One of four main divisions Bracket Entries are sub-divided into.
- e. **CrossFit Open Top-20:** The top-20-finishing and CrossFit Games-invited athletes in the CrossFit Open. CrossFit invites athletes finishing top-20 on their CrossFit Open leaderboard. If an athlete withdraws, fails to accept an invite, is disqualified, or qualifies through National Champion status, CrossFit invites the next successive athlete until all 20 spaces are filled.
- f. **Custom Nike<sup>®</sup> Metcons<sup>™</sup>:** A gift card valued at \$150.00 USD with which a Winner can purchase a pair of *Nike Metcon 4 XD By You* shoes from the store.nike.com website. Winners will also have a choice for a Reebok<sup>®</sup> equivalent.
- g. **Entry:** Represents one selected matchup winner on the challenge Bracket.
- h. **Female Athlete Bracket:** The WODDITY 2019 CrossFit Games Bracket Challenge Bracket featuring female athletes from the CrossFit Games.
- i. **Google Forms:** A specified online survey in which a Submitter uploads a screenshot of their completed Brackets, enters personal contest enrollment information, accepts the terms and conditions of the contest, and opts-in to communications from WODDITY, INC..
- j. **Male Athlete Bracket:** The WODDITY 2019 CrossFit Games Bracket Challenge Bracket featuring male athletes from the CrossFit Games.
- k. **National Champion:** The top male and female athletes from each nation participating in the 2019 CrossFit Open. These athletes and their rankings are administered by CrossFit, INC..
- l. **Nike Gift Card:** A \$150.00 USD award for the winning bracket submissions, sent via email to a winning Submitter after they have responded to an email-based award alert within 48 hours.
- m. **Sanctional<sup>™</sup>:** A CrossFit, INC.-sanctioned qualifying event as administered by an independent party under agreement with CrossFit.
- n. **Sanctional Qualifiers:** Athletes who qualify for the 2019 CrossFit Games through a Sanctional event. The top male and female athlete from each Sanctional receive invites to the CrossFit Games, unless:
  - i. They qualify as a National Champion
  - ii. They qualify as a CrossFit Open Top-20 athlete

- iii. They qualify through a Sanctional which occurred previous to the Sanctional in question, as detailed in the order within 2.b.iv.1 of these terms and conditions.
- o. **Submission:** The upload of a Bracket screenshot and additional Google Forms data provided by the Submitter with intent to enroll in this contest.
- p. **Submitter:** The individual completing the Bracket and Submission with intent to enroll in this contest.
- q. **United States Residents:** Individuals with permanent residence addresses within the United States and its territories.
- r. **Winner:** A Submitter, who's Submission represents the most accurate actual results from the 2019 CrossFit Games standings in either the Male Athlete Bracket for Female Athlete Bracket.

## 2. RULES

- a. Submitters will have until the opening day of the CrossFit Games (12:00 AM Eastern, August 1, 2019) to pick your favorite athletes.
- b. Athletes are divided by their qualification method:
  - i. National Champions
    - 1. The National Champion category features the top-20-ranked male/female athletes, one from each nation, from the 2019 CrossFit Open.
  - ii. CrossFit Open Top-20
    - 1. The CrossFit Open Top-20 category features the top-20-ranked male/female athletes in the 2019 CrossFit Open. This category is adjusted to remove those athletes who:
      - a. Have withdrawn from competition at the time of this contest's launch.
      - b. Have opted to compete as a team.
      - c. Have qualified as one of the top-20 National Champions.
      - d. Have been disqualified from competition by CrossFit, INC. in any way.
      - e. Have not accepted their 2019 CrossFit Games invite.
  - iii. Overflow
    - 1. Because each category is limited to 16 athletes, the Overflow category receives the:
      - a. Bottom-four-seeded male/female athletes from the CrossFit Open Top-20.
        - i. These athletes are ranked first in the Overflow category, as they have placed higher on the overall 2019 CrossFit Open leaderboard than the National Champion top-20 entries.
      - b. Bottom-four-seeded male/female athletes from the National Champion top-20.
        - i. These athletes are ranked second in the Overflow category, as they have placed lower on the overall

2019 CrossFit Open leaderboard than the CrossFit Open Top-20 entries.

2. Because there are only eight total male/female Overflow athletes from the National Champion top-20 and CrossFit Open Top-20 categories, the remaining eight entries in the Overflow Category are populated by:
  - a. Male/female athletes ranking from positions 22 through 29 on the 2019 CrossFit Open National Champion leaderboard.
  - b. These athletes are ranked third in the Overflow category, as they have placed lower on the overall 2019 CrossFit Open leaderboard than the CrossFit Open Top-20 entries and the overall 2019 CrossFit Open National Champion Top-20 entries.

iv. Sanctional Qualifiers

1. The list of male/female Sanctional Qualifiers athletes are sourced from the top finishers at each of CrossFit's 2019 season sanctioned qualifier (Sanctional) events. Those events, in order of ranking, are:
    - a. Dubai CrossFit Championship
    - b. Wodapalooza CrossFit Festival
    - c. Australian CrossFit Championship
    - d. CrossFit Fittest in Cape Town
    - e. CrossFit Strength in Depth
    - f. Mid Atlantic CrossFit Challenge
    - g. CrossFit Italian Showdown
    - h. Asia CrossFit Championship
    - i. Reykjavik CrossFit Championship
    - j. Brazil CrossFit Championship
    - k. Down Under CrossFit Championship
    - l. The Rogue Invitational
    - m. The CrossFit Lowlands Throwdown
    - n. The Granite Games
    - o. CrossFit French Throwdown
  2. Because the 2019 CrossFit Games season only includes fifteen Sanctional events, the sixteenth entry of the Sanctional Qualifiers category will include the 21<sup>st</sup>-ranked male/female athlete on the 2019 CrossFit Open National Champion leaderboard.
- c. **IMPORTANT:** Because CrossFit works on points system and does not have a true elimination system, matchup winners will be based on which athlete outperforms the other athlete in total points. For example: Sara Sigmundsdottir is matched up against Annie Thorisdottir. If Annie is higher on the final CrossFit Games leaderboard, she will have "defeated" Sara in their matchup.

- d. We will give a pair of Custom Nike Metcons away for the top submission in the Male Athlete Brackets and the top submission in the Female Athlete Brackets.
  - i. “Custom Nike Metcons” represents a gift card to purchase a pair of *Nike Metcon 4 XD By You* shoes from the store.nike.com website.
  - ii. *Nike Metcon 4 XD By You* shoes have an estimated valued at \$150 USD, per pair. A \$150.00 Nike Gift Card will be issued in that value to qualified winners via electronic mail. This is not exchangeable for any other gift card or monetary payment.
  - iii. Winners have full autonomy to purchase a product of their choice with their \$150.00 USD Nike Gift Card, whether on the Nike website or at a Nike Gift Card-accepting physical Nike location.
  - iv. WODDITY, INC. does not assume responsibility for the sizes, colors, designs, and general availability of the *Nike Metcon 4 XD By You* shoe. Should any combination of size, color, design, or general availability not be in-stock or labeled as “available” on the Nike website or at a Nike gift card-accepting physical Nike location, Winners should exercise their full autonomy to purchase a different product(s) of their choice from the Nike website or at a Nike Gift Card-accepting physical Nike location.

### **3. SUBMISSIONS**

- a. Submissions must be received via upload to the specified Google Forms survey.
- b. Submissions should be uploaded to the Google Forms survey here:

- c. Submission requirements:
  - i. Submissions must be an un-doctored screen capture/screen grab of your completed and submitted Bracket.
  - ii. Submissions must be in .PNG, .JPG, or .JPEG file formats.
  - iii. Submissions must be legible.
  - iv. Submissions must be received before 12:00 AM on the 1<sup>st</sup> of August, 2019.
  - v. Submissions for this challenge are limited to one Male Athlete Bracket and one Female Athlete Bracket per individual.
  - vi. Submissions not meeting these criteria will be automatically disqualified.

### **4. ELIGIBILITY**

- a. Awards for this challenge are only applicable to United States Residents.
- b. Awards for this challenge will be sent via electronic mail to the winner’s submitted email address.
  - i. WODDITY, INC. will send an email to confirm a recipient’s inbox is monitored prior to sending a Nike Gift Card award.
    - 1. Awardees have 48 hours to acknowledge receipt of the email or they will forfeit their award.
- c. Submission Acknowledgments
  - i. Upon submission of a Bracket for WODDITY’s 2019 CrossFit Games Bracket Challenge, Submitters accept responsibility for:

1. The accuracy of the information completed on the submission form. Typos and incorrect/invalid information are not the responsibility of WODDITY, INC..
- ii. Submitters are automatically enrolled in the WODDITY email database and will receive corresponding email newsletters, updates, and future promotions.
- iii. Winners will be published on WODDITY.com and associated WODDITY, INC. web properties and social media. By accepting the terms and conditions detailed herein via check-box during Bracket Submission, Submitters opt-in to the use of their likeness in these announcements.
- iv. WODDITY, INC. accepts responsibility for:
  1. Reaching out to submission winners within 30 calendar days of the close of the 2019 CrossFit Games. The 2019 CrossFit Games are scheduled to close on August 4<sup>th</sup>, 2019. Winners should expect to be contacted by September 3<sup>rd</sup>, 2019. Confirmations will be sent via electronic mail to the submitted email address.
- v. WODDITY, INC. does not assume responsibility for:
  1. The duration to which Nike will honor awarded Nike Gift Cards.
  2. Guaranteed-accurate vetting of redundant or excessive Submitter submissions. However, we will do our best to ensure this contest is fair for all Submitters.
    - a. WODDITY, INC. will use all conventional means available to disqualify duplicate and excessive Submissions.
